



**TURF MASTER INC. ROLL-OFF DUMPSTER**  
**TERMS OF SERVICE AGREEMENT**

**Customer must call when ready for dumpster to be picked up!**

**DUMPSTER SIZES**

10 Yard, 13 Yard, 15 Yard & 20 Yard (5 ton weight limit) - Will Fit Most Driveways

**Dumpster Fees:**

**\$375** Dumpster Rental Fee for 10 Yard, **\$425** Dumpster Rental Fee for 13 Yard, **\$450** for 15 Yard, or **\$525** for 20 Yard (up to 10 miles) Additional fees apply for 10 to 20 miles & 20 to 30 miles. Rental fee due upon rental of dumpster. Payable by credit or debit card. (Customers may pay via check but will need to leave a credit or debit card on file with us for any additional disposal fees.) Rental fee **includes disposal of up to 1 ton for 10 Yard & 13 Yard, 1.5 tons for 15 Yard, & 2 tons for 20 Yard dumpsters.**

Dumpster rental fee provides a **rental period of up to 10 days. Customer must call when they are ready for dumpster to be removed.** A \$7 per day additional fee will be charged for each day over rental period. At time of pick up, dumpster dumping fees over the included tonnage will be charged to the credit or debit card on file in accordance with the amount currently charged by the dump site. (Currently @ \$135/ton for construction/household items, \$70/ton for brush only, & \$60/ton for soil only). Any late fees, fees for disallowed items (mattresses, tires, etc.) or additional fees incurred as a result of overfilling dumpster or exceeding allowable weight limit will also be charged at that time. *See brochure for explanation of additional fees that may be incurred.*

**Terms & Conditions For Service Dumpster**

Waste Material- Customer represents and warrants that the materials placed in the equipment shall be “waste material” as defined herein and shall contain no other substances. The term “waste material” as used in these Term & Conditions shall mean solid waste generated by Customer excluding radioactive, volatile, highly flammable, explosive, biomedical, infectious, toxic or hazardous material. The term “hazardous material” shall include, but not limited to, any amount of waste listed or characterized as hazardous by the United States Environmental Protection Agency or any state agency pursuant to the Resource Conversation and Recovery Act of 1976, as amended or applicable by law. Title to the liability for any waste excluded above shall remain with Customer and Customer expressly agrees to defend, indemnify, and hold harmless Turf Master Inc. from and against any and all damages, penalties, fines, and liabilities resulting from or arising out of such waste excluded above.

Driveways and parking areas- Customer warrants that any access / location provided for Turf Master Inc.’s equipment is sufficient to bear the weight of all equipment and vehicles required to perform the service. Turf Master Inc. shall not be responsible for any damage to any private pavement or accompanying sub-surface or any route reasonably necessary to provide the services herein contracted. In addition, Turf Master Inc. shall not be responsible for damages to lawn, fences, or shrubbery. Customer assumes all liabilities for damage to pavement or road service, lawns, fences, and shrubbery, including but not limited to any runoff or drainage at the time dumpster removal.

**Disclaimer**

Due to the uncertain soil conditions and sub surface terrain, Turf Master Inc. cannot be held responsible for any damage to customer driveways, curbs, lawns, or walks, wells and septic systems. It is the customer’s responsibilities to make Turf Master Inc. aware of any underground utilities, which might be affected by taking delivery of the dumpster/container.

**Delivery & Pick-up days are Monday thru Friday.** Rental period of 10 days is included in rental fee but customer can keep it as long as they need. **We do not pick up until customer calls!** Customer will be charged an additional per-day service fee for additional time as well as dump fee equivalent to amount charged by dump site. Customer is liable for additional fee for container over allowable weight limit. **Customer must call when ready for dumpster to be picked up.**
